Information pursuant to Legislative Decree no. 196/03 “Personal Data Protection Code”

With reference to the provisions of article 13 of the above-captioned legislative decree, Fondazione Accademia Nazionale di Santa Cecilia (hereinafter for the sake of brevity “Accademia”) does hereby inform you that the personal data acquired in connection with your status as _____ member, and the other data that may be collected by us during this relationship, are subject to processing by us for the purposes of managing your rewards as established by the benefits for your category, as well as for all legal requirements connected with civil, tax, and accounting regulations.

These data processing operations take place in scrupulous compliance with the principles of confidentiality and security required by the aforementioned law, and in line with the principles of fairness and lawfulness of processing adopted by Accademia.

Processing shall take place through the collection of the personal data on paper and their subsequent introduction into one or more automated personal computer systems networked locally and to Accademia’s central processors.

Your personal data will be disseminated solely as per the terms established by the benefits of your category, and to provide information of your status to the public.

Moreover, they may be disclosed to professional offices and to accounts auditing and financial statement certification companies.

The conferral of the personal data as per this information notice is of an obligatory nature, and the consent of the data subject is not required for it, pursuant to sect. 24, paragraph 1, letter b) (“*processing necessary for the performance of obligations resulting from a contract to which the data subject is a party*”).

With regard to the data that are the object of the processing pursuant to this information notice, you may at all times exercise the rights established by Sect.7 of the aforementioned decree. In particular, having confirmed by virtue hereof the existence of your personal data at Accademia and of the processing logic applied thereto and the purposes thereof, you may obtain from the data controller identified below communication of such data in intelligible form. You may also obtain the erasure, anonymization, or blocking of the data that have been processed unlawfully, or obtain the updating, rectification or, where interested therein, integration of the data; you may also object to processing, on legitimate grounds.
